HAVE YOUR SAY ON THE TNRD BUDGET

The TNRD is in the process of building the 2024 Budget, and we want you to learn about the budget, ask questions, and offer feedback.

Did You Know? Property owners only pay the TNRD for services that they receive, whether they are within an Electoral Area or Member Municipality. A large portion of your TNRD tax bill goes towards solid waste management and library services. Further, you may also pay larger portions for fire protection, community parks, or curbside waste collection. All service areas contribute to overall administration costs which are necessary to provide these TNRD services.

KEEPING MORE WASTE OUT OF THE LANDFILL

The TNRD is working to prevent hazardous waste and recyclable materials from being landfilled or disposed of improperly. Currently, the TNRD is looking to expand products that are included in Mandatory Recyclable Materials Bylaw No. 2743, to include all materials within the extended producer responsibility (EPR) program. Extended Producer Responsibility (EPR) is an approach to recycling that requires producers, such as manufacturers, distributors, and retailers to take responsibility for the life cycle of the products they sell.

As part of the proposed bylaw amendment, mandatory recyclables would include EPR products such as: antifreeze and antifreeze containers, batteries, flammable liquids, fluorescent lights, gasoline and diesel, residential pesticide products, refundable beverage containers, pharmaceutical products, oil, oil filters and containers, paint, electronics and electrical products (including metal appliances), thermostats, and tires. The

proposed amendment to the bylaw would also include residential packaging and printed paper.

What does this mean? The expanded disposal ban would be enforceable at solid waste facilities in the Thompson-Nicola region. Collectors and haulers will be responsible for the contents of the loads of refuse that are brought to facilities for disposal. If the bylaw is amended, loads containing EPR materials, or more than 10% being residential packaging, printed papers, cardboard, or beverage containers, may be subject to a fine. Loads containing large and hazardous EPR materials such as electronics, outdoor power equipment, small electrical appliances, paint, etc. may be subject to a fine per item.

Expanding the disposal ban for recyclables will also help bring down the TNRD's per-capita waste generation. In 2020, the per-capita landfill disposal rates of TNRD residents was 671 kilograms per year, which

is 34% higher than the per-person average across B.C. and makes the TNRD the fifth-largest waste producer, on a per-person basis, compared to all 27 regional districts.

The Mandatory Recyclable Materials Bylaw was implemented over three phases in 2022, following public consultation, and currently only includes corrugated cardboard. This bylaw is a key waste reduction strategy that was identified in the TNRD's 2018 Regional Solid Waste Management Plan.

The TNRD held four online public information meetings in fall 2023, conducted a public survey, and developed a resource package for commercial haulers of waste. Opportunities to ask questions and learn more are always ongoing. ASSESSING OUR ACCESSIBILITY

The Accessibility Advisory Committee is now in place, with 11 members who are advising on accessibility needs within the TNRD. The regional district is in the process of creating an Accessibility Plan with guidance from this committee, which will identify barriers to accessibility and inclusion that may be experienced by the public or regional district staff.

As part of this process, the TNRD will be evaluating accessibility in its facilities and digital platforms. Public facilities that are within jurisdiction of the TNRD include libraries, Eco-Depots and Transfer Stations, several parks, community halls and cemeteries, and the TNRD Civic Building.

The TNRD FireSmart program has been exceptionally busy in 2023 to help residents keep their property safe from the threat of wildfire.

FireSmart Coordinator Dan Funk has spent many weeks providing educational fire risk assessments for private property owners in TNRD Electoral Areas, and has had a booth at several dozen community events throughout the regional district. Dan has given FireSmart presentations to communities within the Wildland Urban Interface, visited 10 area fire departments, set up a booth at 10 Thompson-Nicola libraries, and answered hundreds of FireSmart inquiries.

LOON LAKE FIRE HALL NOW COMPLETE!

We're thrilled that the Loon Lake Fire Hall is now completed! Occupancy has now been granted to the fire hall, and it is expected that the Loon Lake Fire Hall will be operational before the end of 2023.

The new fire hall is located on Loon Lake Road near the centre of the lake. The TNRD has applied to the Fire Underwriters Survey (FUS) for this new fire hall location, which will expand potential insurance benefits to property owners in proximity of the hall. We strongly encourage residents to contact their insurance broker with specific questions regarding insurance costs for their property.

The new fire hall is critical for Loon Lake and residents of the community, and we're grateful to the Loon Lake Fire Department for their dedication while anticipating completion of this project for several years.
